AN ORDINANCE APPROVING THE CONSOLIDATION PLAN OF E. RODRIGUEZ, INC. WHEREAS, ocular inspection conducted and verified disclosed that the project site has been occupied by informal settlers who have organized themselves into an suscintion known as PINAGKAISA HOMEOWNERS ASSOCIATION, INC.;

WHEREAS, said homeowners association has entered into a MEMORANDUM OF AGREEMENT" with the registered lot owner which is now under negotiation with the National Home Mortgage Finance Program (NHMFP) under the Community Mortgage Program (CMP);
