ORDINANCE NO. SP 1155 S-2002

AN ORDINANCE AMENDING ORDINANCE NO. SP-280, S-95, BY MODIFYING THE IMPLEMENTATION DATE OF THE BARANGAY DAY FROM JUNE 25 TO OCTOBER 2 EFFECTIVE OCTOBER 2, 2002 AND EVERY OCTOBER 2ND OF EVERY YEAR THEREAFTER.

Introduced by Councilors ALMARIO E. FRANCISCO, VINCENT P. CRISOLOGO, VICTOR V. FERRER, JR., ELIZABETH A. DELARMENTE, BERNADETTE HERRERA-DY, ERIC Z. MEDINA, JORGE L. BANAL, JULIAN M.L. COSETENG, WENCEROM BENEDICT C. LAGUMBAY, DANTE M. DE GUZMAN, JESUS "Bong" C. SUNTAY and JANET M. MALAYA.

WHEREAS, the celebration of the Barangay Day will be more fittingly held in October of each year, it being declared as the Local Government Month by virtue of Presidential Proclamation No. 114 issued on October 10, 2001, signed by Executive Secretary Alberto G. Romulo, for and by authority of the President of the Republic of the Philippines;

WHEREAS, the City Government, thru the City Mayor and the City Council, desire to give due recognition to the vital contributions of barangay officials to nation-building; and

WHEREAS, the forging of stronger ties among all local elective officials will redound to the benefit of all those residing and doing business in the city.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Section 1 of City Ordinance No. SP-280, S-95, is hereby amended, to read as follows:

"Sec. 1. - It is hereby declared that effective October 2, 2002 and every October 2nd of every year thereafter, shall be celebrated as Barangay Day in Quezon City."

SECTION 2. Section 2 of City Ordinance No. SP-280, S-95, is hereby

"Sec. 2 - A Steering Committee is hereby created for this purpose, composed of the City Mayor or his representative to the Executive Body, with the Head of the Barangay Operations Center and the Liga President as Chairman and Co-Chairman, respectively, and its other members to be appointed by the City Mayor to thresh out the details of the celebration."

SECTION 3. All other provisions of City Ordinance No. SP-200, S-95, not specifically amended shall remain in full force and effect.

SECTION 4. This Ordinance shall take effect immediately upon its approval.
