**ORDINANCE NO. SP 1156, S-2002**

**ORDINANCE RENAMING KENTUCKY STREET IN BARANGAY DEL MONTE, DISTRICT 1, QUEZON CITY TO ERNESTO PORTO STREET.**

Introduced by Councilor **ELIZABETH A. DELARMENTE, WILMA AMORANTO-SARINO, VINCENT P. CRISOLOGO, VICTOR V. FERRER, JR., BERNADETTE HERRERA-DY, ROMMEL R. ABESAMIS, JORGE L. BANAL, JULIAN M.L. COSETENG and JESUS MANUEL MANUEL C. SUNTAY.**

WHEREAS, the Barangay Council of Barangay Del Monte, District 1, of this City has passed Resolution No. 48, S-99, expressing the desire to rename Kentucky Street to Ernesto Porto Street;

WHEREAS, a copy of Barangay Del Monte's Resolution No. 48, S-99 is hereto attached as Annex "A";

WHEREAS, according to the said Resolution, Ernesto Porto, aside from once being a Teniente del Barrio in the said area in the 1960's, was one of the most well-known sportsmen of his generation, having represented the Philippines in the 1948 London Olympics, the 1952 Helsinki Olympics and the 1954 Asian Games;

WHEREAS, Ernesto Porto died of a heart attack on February 5, 1973, as attested by a copy of a Certificate of Death hereto attached as Annex "B";

WHEREAS, consultation with the National Historical Institute was already made regarding the desired change of street name;

WHEREAS, the desire to rename Kentucky Street, is in part, prompted by patriotic sentiments on the part of the barangay council;

WHEREAS, renaming Kentucky Street to Ernesto Porto Street will serve to commemorate and honor a man who, by the account of his own community, has served as an example to the citizenry.




NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED,


Section 1. Kentucky Street in Barangay Del Monte, District 1, Quezon City is hereby renamed to Ernesto Porto Street.
