AN ORDINANCE RENAMING NEW YORK STREET IN DISTRICTS III AND IV, QUEZON CITY, TO PABLO P. REYES, SR. STREET.

WHEREAS, the Honorable City Council received a letter from the Honorable City Mayor requesting that the memory of Pablo P. Reyes, Sr., be immortalized by renaming a city street after him;

WHEREAS, Pablo P. Reyes, Sr., was the first City Superintendent of Schools of Quezon City, serving in that capacity from 1950 to 1962 when he retired at the age of 65. He died in 1969 at the age of 72;

WHEREAS, the late Supt. Reyes, Sr. who was a devoted elementary school teacher in the City of Manila, was appointed high school principal in Cabanatuan City, Nueva Ecija in 1939. All throughout the Second World War, he Reyes, Sr. continued to serve in the public school system, becoming Assistant Superintendent of Manila in 1942. He became the first City Superintendent of Quezon City in 1950, holding office at the then Cubao Public High School, now the Ramon Magsaysay Public High School;

WHEREAS, commemorating the life of a man like Pablo P. Reyes, Sr., who dedicated his whole self to the teaching profession, will serve as a timely and significant reminder to all, especially the young, of the nobility of the Filipino and an inspiration to our present-day public school teachers in the pursuit of their endeavors in the service.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

Section 1. This Ordinance shall be known as the Pablo P. Reyes, Sr., Street Ordinance.

Section 2. New York Street located in Districts III and IV, Quezon City, is hereby renamed to Pablo P. Reyes, Sr. Street after the first City Superintendent of Schools of Quezon City.

Section 3. The City Secretary is hereby requested to furnish a copy of this Ordinance to all concerned government officials and the family of the late Supt. Pablo P. Reyes.

Section 4. This Ordinance shall take effect after fifteen (15) days following its publication in a newspaper of general circulation.
