ORDINANCE NO. SP. 1176s-2002

IN ORDINANCE CREATING A SPECIAL TRUST FUND OUT OF THE ROCEEDS FROM THE PAYMENTS FOR THE VALUE OF THE CITY SOLD DIRECTLY LOTS GOVERNMENT OCCUPANTS/RESIDENTS THEREOF, AS WELL AS THE ORIGINATION HES DERIVED FROM COMMUNITY MORTGAGE PROGRAM PROJECTS DRIGINATED BY THE QUEZON CITY GOVERNMENT WHICH SHALL BE RESERVED AND USED EXCLUSIVELY FOR THE DEVELOPMENT AND HOUSING PROJECTS COMMUNITY THE OF MPROVEMENT CONCERNED UPON PRIOR ALLOCATIONS BY THE CITY COUNCIL INDER APPROPRIATE ORDINANCES.

WHEREAS, the Quezon City government from time to time disposes of main city government lots by direct sale in favor of the qualified mapants/residents thereof;

WHEREAS, the Quezon City government likewise derives revenues in the hm of Origination Fees from the Community Mortgage Program (CMP) under tentional Home Mortgage Finance Corporation of the government;

WHEREAS, the law does not define nor direct the specific disposition of but these funds;

WHEREAS, it is only just and proper that said funds be constituted into a special Trust Fund to be used exclusively for the development and improvement of the communities where the buyers reside, in order to attain the vision of a pulity community in Quezon City.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN

SECTION 1. There is hereby created a Special Trust Fund out of the posseds from the payments for the value of the city government lots directly sold a qualified occupants/residents and the origination fees from the Community langue Program (CMP) projects originated by the Quezon City Government.

SECTION 2. This Special Fund shall be reserved exclusively for the brelopment and improvement of community housing projects, the necessary mounts therefor to be allocated by the City Council under appropriate ordinances, moided; however, that the main contributors to the fund shall be given priority.

SECTION 3. The Chairpersons of the Committee on Appropriations, lumittee on Laws Rules and Internal Government, Committee on Ways and lum, Committee on Subdivision and Housing, Committee on Urban Poor are uted to formulate the implementing rules and guidelines of the trust fund with h thiman of the Committee on Laws as head, and a member of the minority MD is part of the committee.

SECTION 4. This ordinance shall take effect upon its approval.
