## ORDINANCE NO. SP. 1179, S-2002

WORDINANCE ESTABLISHING THE QUEZON CITY MUSEUM UNDER IN OFFICE OF THE CITY MAYOR FOR THE PURPOSE OF EXHIBITING IN HISTORICAL, CULTURAL AND NATURAL ASSETS OF THE CITY, WID APPROPRIATING THE AMOUNT OF TEN MILLION PESOS 10,000,000,00) FOR THE PURPOSE.
