ORDINANCE NO. SP 1180 S-2002

AN ORDINANCE APPROPRIATING THE AMOUNT OF TWO HUNDRED THIRTEEN THOUSAND NINE HUNDRED TWENTY-NINE PESOS AND FIFTY-SIX CENTAVOS (P213, 929.56) FOR THE ASPHALT OVERLAY OF GALINO STREET, BARANGAY BALINGASA, QUEZON CITY, TO BE TAKEN FROM ANY AVAILABLE FUND OF THE CITY TREASURY.

WHEREAS, Section 438 (a)(5)(v) of RA 7160, known as the Local Government Code of 1991, states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances which shall ensure the efficient and effective delivery of the basic services and facilities; shall regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same;"

WHEREAS, there is an urgent need for the Asphalt Overlay of Galino Street, Barangay Balingasa, Quezon City to have the safety and convenience of innumerable people passing in and out of the road;

WHEREAS, the City Engineer has estimated that the project will cost P213,929.56 that includes; Squaring; which amount is not available in any existing appropriation.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

Section 1. There is hereby appropriated the sum of Two Hundred Thirteen Thousand Nine Hundred Twenty-Nine Pesos and Fifty-Six Centavos (P213,929.56) for the asphalt overlay of Galino Street, Barangay Balingasa, Quezon City.





Section 2. This Ordinance shall take effect immediately upon its approval.




