ORDINANCE NO. SP **1192**, S-2002

AN ORDINANCE AMENDING SECTIONS 1, 4, 5 AND 6 OF CITY ORDINANCE NO. SP-906, S-2000, BY ADAPTING THE MODIFICATIONS PROVIDED IN CITY ORDINANCE NO. SP-1155, S-2002.

WHEREAS, Ordinance No. SP-280, S-95 was amended by Ordinance No. SP- 1155, S-2002 changing the celebration of Barangay Day in Quezon City from June 25, 1995 and every June 25th of every year thereafter to October 2, 2002 and every October 2nd of every year thereafter;

WHEREAS, there is a need to amend Ordinance No. SP-906, S-2000 in order to adjust to the provision set in Ordinance No. SP-1155, S-2002.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Sections 1, 4, 5 and 6 of Quezon City Ordinance No. SP- 906, S-2000 are hereby amended to read as follows:

- "Section 1. - Citation and cash awards are hereby given to the outstanding and deserving Punong Barangay, Barangay Kagawad and Sanggunian Kabataan Official in every district of Quezon City as part of the culminating activity of the annual celebration of Quezon City Barangay Day effective October 2, 2002 and every October 2nd of every year thereafter."
- "Section 4. - A Special Committee for this purpose is hereby created to assess and judge the qualifications of nominees/candidates on District Level based on the above-cited criteria. This Special Committee shall be composed of the President ng Liga ng mga Barangay, as Chairman; President of the Federation of Sangguniang Kabataan as Co-Chairman; the Majority Floor Leader and Minority Floor Leader of the City Council and one (1) representative each from the Office of Barangay Operations Center, Community Relations Office and Office of the Mayor, as Members."
- "Section 5. - The candidates for the three (3) categories shall be judged on the basis of their yearly performance effective August 1, 2002 to August 31, 2003, and every year thereafter.
- "Section 6. - The winners on the three categories will each receive a plaque of recognition and a cash prize amounting to Fifty Thousand Pesos (P50,000.00) each, as follows:

OUTSTANDING PUNONG BARANGAY

1 winner/District - 4 x P50,000.00 = P 200,000.00

OUTSTANDING BARANGAY KAGAWAD

1 winner/District - 4 x P50,000.00 = P 200,000.00

**OUTSTANDING SANGGUNIANG KABATAAN




SECTION 2. All other provisions of City Ordinance No. SP-906, S-2000, not specifically amended shall remain in full force and effect.

SECTION 3. This Ordinance shall take effect upon its approval.


