AN ORDINANCE GRANTING EXEMPTION TO THE MARECO BROADCASTING NETWORK FROM THE PAYMENT OF AMUSEMENT TAX FOR THE CONCERT OF "CROSS LIVE TOUR-MARTIN NIEVERA XV EVER" HELD ON FEBRUARY 2, 2002, AT THE ARANETA COLISEUM, CUBAO, QUEZON CITY.


WHEREAS, Section 192 of RA. 7160, otherwise known as the Local Government Code of 1991, provides the authority of the Council, through an ordinance duly approved, to grant tax exemption, incentives or reliefs under such terms and conditions deemed necessary;

WHEREAS, MARECO BROADCASTING NETWORK, the sponsoring entity of the mentioned concert has committed to donate the exempted amusement tax to GOODWILL INDUSTRIES OF THE PHILIPPINES, Inc., a non-stock, non-profit organization organized for the purpose of providing rehabilitation services, training employment of disabled, handicapped and disadvantaged;

WHEREAS, Goodwill Industries of the Philippines, Inc., the beneficiary of the concert has pledged to prioritize and undertake its social and community programs to various barangays of Quezon City.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. An amusement tax exemption is hereby granted to the MARECO BROADCASTING NETWORK, for the concert of "Cross Over Live Tour - Martin Nievera XV Ever," held on February 2, 2002, at the Araneta Coliseum, Cubao, Quezon City.



SECTION 3. This ordinance shall take effect upon its approval.


