CERTIFICATION

WHEREAS, Ordinance No. SP-1168, S-2002, required all cinema owners and operators within the jurisdiction of Quezon City to increase their theater admission fee by One Peso (P1.00) covering the period from October 1 to 31, 2002 for the purpose of raising funds to finance the programs and activities of the Boy Scouts of the Philippines, Quezon City Chapter;

WHEREAS, the above-mentioned ordinance was finally passed by the City Council on September 17, 2002 and signed by His Honor, the City Mayor on September 30, 2002;

WHEREAS, the cinema owners did not implement the ordinance for reason that there was a delay in the transmittal of the said ordinance.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION DULY ASSEMBLED:


SECTION I -- Section 1 of Ordinance No. SP-1168, S-2002 is hereby amended, to read as follows: "All cinema owners and operators are hereby required to increase their theater admission fee by ONE PESO (P1.00) covering the period from JANUARY 1 to 31, 2003".

SECTION 2. The City Treasurer is hereby directed to remit the same to the Boys Scout of the Philippines, Quezon City Chapter.


SECTION 3. - This amendment shall take effect immediately upon its approval.




