ORDINANCE NO. SP-1206S-2002

AN ORDINANCE DECLARING 12<sup>th</sup> STREET FROM DOÑA HEMADY AVENUE GOING TOWARDS THE DIRECTION OF E. RODRIGUEZ AVENUE, BARANGAY MARIANA, QUEZON CITY, AS A ONE-WAY STREET.

WHEREAS, Section 21 (d) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that, any city xxx may, by a duly enacted ordinance, xxx regulate the use of any local street, road and thoroughfare;

WHEREAS, Barangay Council of Barangay Mariana Quezon City has passed a resolution urging the Quezon City Council to pass an ordinance to make 12<sup>th</sup> Street of said barangay a one-way street, from Doña Hemady to E. Rodriguez Quezon City;

WHEREAS, 12<sup>th</sup> street corner E. Rodriguez Avenue, Barangay Mariana, District IV, this city, tends to become an accident-prone area when vehicles coming from E. Rodriguez Avenue in the direction of Cubao make a sharp right turn at 12<sup>th</sup> street. Likewise, when the vehicles coming from E. Rodriguez Avenue to the direction of Mabuhay (Welcome) Rotonda make a left-turn to the direction of 12<sup>th</sup> street;

WHEREAS, Doña Hemady Avenue is one-way street from E. Rodriguez Avenue going to Aurora Boulevard, and can provide safer access to the direction of 12<sup>th</sup> street;

WHEREAS, the approval of this ordinance is imperative to prevent vehicular accident in 12<sup>th</sup> street corner E. Rodriguez, Avenue, Quezon City.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

Section 1. DECLARATION AS A ONE WAY STREET. - 12<sup>th</sup> Street from Dona Hemady Street going towards the direction of E. Rodriguez Avenue, Brgy. Mariana, Quezon City, is hereby declared as a one-way street.


Section 2. INSTALLATION OF ONE-WAY STREET SIGN. - The Department of Public Order and Safety (DPOS) is hereby mandated to install a one-way street sign on both ends of the street mentioned to inform the motorists using the same.

Section 3. EFFECTIVITY. - This Ordinance shall take effect immediately upon its approval.




