ORDINANCE NO. SP-1212s-2002

AN ORDINANCE CREATING AN AD HOC COMMITTEE TASKED TO CODIFY QUEZON CITY ORDINANCES, APPROPRIATING THE AMOUNT OF TWO HUNDRED FORTY-SIX THOUSAND PESOS (P 246, 000.00) OR SO MUCH AS MAY BE NECESSARY FOR SAID PURPOSE, AND FOR OTHER PURPOSES.

WHEREAS, there are now many ordinances which have been enacted by the Quezon City Council since the start of its existence as a component of the local government of Quezon City;

WHEREAS, many of said ordinances fall under the category of regulatory measures which regulate the establishment, conduct and operation of commercial and business establishment, and other corporate entities, define the relationship of the Quezon City Government and its citizens, and provide for the conduct and behavior of the people within the territorial jurisdiction of the city;

WHEREAS, many of said ordinances have undergone changes, or amendments, in the course of time to update them with present day exigencies;

WHEREAS, there has been a long felt need for the codification of said ordinances for the proper guidance of everyone, to the end that the various ordinances, together with their amendments, on a particular subject may be presented in full context and proper perspective;

WHEREAS, it is now high time, after all these years, that the matter of codification of the Quezon City ordinances be given serious thoughts and carried out in earnest.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED,

SECTION 1. COMPOSITION. - There is hereby created an AD HOC COMMITTEE of the Quezon City Council which shall hereinafter be called the Quezon City Council Ad Hoc Committee On Ordinance Codification, the composition of which shall be as follows:

SECTION 2. COMMITTEE WORKING GROUP. - The Chairman of the Quezon City Council Ad Hoc Committee On ordinance Codification, with the concurrence of its members, is hereby authorized to designate such personnel from their respective offices or the office of the City Secretary, or any other office, consisting of one (1) Secretariat Head and Five (5) members, to constitute as the Working Group of said Committee which shall assist the same in the performance of its functions as defined in this ordinance.

SECTION 3. FUNCTIONS. - The Quezon City Council Ad Hoc Committee on Ordinance Codification shall discharge, exercise and perform the following functions, responsibilities and duties:

- (a) Inventory and collate all existing ordinances which have been enacted by the Quezon City Council since the start of its existence as a component of the local government of Quezon City up to the present;
- (b) Classify, categorize and sort out ordinances according to subject, or under such other classification or categorization as may be deemed necessary and expedient;

- c) Collate all amendments to each and every ordinance and accordingly make the necessary adjustments to the original or mother ordinances pursuant to such adjustments;
- d) Undertake any and all such actions or measures which are necessary to be taken towards the final codification of said ordinances;
- e) Print or cause to be printed in book form said Quezon City Ordinances as codified;
- f) Submit said Quezon City Ordinances as codified, and its report on said codification to the Quezon City Council;
- g) Perform such other tasks or duties as may be assigned by the Presiding Officer of the Quezon City Council in connection with said ordinance codification.

SECTION 4. TIME FRAME. - The Ad Hoc Committee herein created shall endeavor to finish its task, and submit its report to the City Council, within a period of six (6) months from the approval of this ordinance.

SECTION 5. HONORARIA. – The Head of the Secretariat and members of the Working Group are hereby authorized to receive honoraria at the rate hereunder provided, or so much as may be authorized under existing rules and regulations, charged against the appropriation herein provided.

SECTION 6. APPROPRIATION. – The amount of Two Hundred Forty Six Thousand Pesos (P246,000.00) shall be included in the appropriation for the Quezon City Council in the 2003 Annual Budget of Quezon City, under item, "Other Expenses."

SECTION 7. REPEALING CLAUSE. - The provision of any ordinance local Elective Order or issuance which may be inconsistent with the provision of this ordinance are hereby repealed or amended accordingly.
