AN ORDINANCE APPROPRIATING FUNDS FOR THE DEVELOPMENT OF THE LA LOMA LECHON BUSINESS CENTER TO SERVE AS ONE OF THE TOURIST SPOTS IN METRO MANILA.

WHEREAS, the present state of the establishments and surroundings require its redevelopment to enhance the physical attribute of the business area while having its own distinction as lechon center in Metro Manila, if not in the Philippines;

WHEREAS, the lechon business owners have expressed their desire to uplift the present condition of their business areas and have committed to support the plan initiated by the Market Development and Administration Department;

WHEREAS, the development plan will boost the lechon industry and will serve as one of the tourist spot in the city.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The La Loma lechon business area will be developed in terms of physical structures, environmental condition, roads, lighting and other relative aspects.

SECTION 2. The Market Development and Administration Department shall be the lead agency and will prepare and implement the development plan in coordination with the City Engineering Department, City Planning and Development Office and other government agencies concerned.

SECTION 3. This ordinance shall take effect upon its approval.
