ORDINANCE NO. SP-1223S-2002

AN ORDINANCE GRANTING THE SOLOMON SPORTS AND LEISURE CORPORATION A FRANCHISE TO ESTABLISH, CONSTRUCT, OPERATE AND MAINTAIN A SPORTS CENTER AND ARENA LOCATED AT SARMIENTO STREET, BARANGAY STA. MONICA, NOVALICHES, QUEZON CITY, AND PRESCRIBING THE RULES AND REGULATIONS THEREFOR.

WHEREAS, Solomon Sports and Leisure Corporation duly organized and existing under the virtue of the Philippine Laws with office address at Sarmiento Street, Barangay Sta. Monica, Novaliches, Quezon City;

WHEREAS, one of the objectives of the Solomon Sports and Leisure Corporation is the development and promotion of desirable moral and cultural values through the establishment of sports leisure and recreational facilities, centers and areas;

WHEREAS, the residents of Novaliches need additional and alternative modes, of entertainment and their needs can be satisfied if there is a variety of sports, entertainment and/or recreational places and venues;

WHEREAS, boxing, basketball, ballroom, dancing, cockfighting and other similar activities have been and remain popular, traditional and customary forms of recreation and entertainment among Filipinos during legal holidays, local fiestas, agricultural, commercial and industrial fairs, carnivals or expositions.

WHEREAS, for the purpose of holding regulated sports activities, the Sangguniang Panlungsod, pursuant to Section 458, sub-par (5) of Republic Act No. 7160, is empowered to authorize and license the establishment, operation and maintenance of cockpits and regulate cockfighting, among others.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED,

SECTION 1. The Solomon Sports and Leisure Corporation is hereby granted a franchise to establish, construct, operate and maintain a sports center and/or an arena for cockfighting located at Sarmiento Street, barangay Sta. Monica, Novaliches, Quezon City, for a period of twenty five (25) years.


SECTION 2. The Solomon Sports and Leisure Corporation shall secure a Mayor's permit for the establishment and construction, operation and maintenance of the above-mentioned center and/or arena.

SECTION 3. This ordinance shall take effect immediately upon its approval.


