AN ORDINANCE NAMING THE BRIDGE CONNECTING BARANGAYS SAN ANTONIO AND KATIPUNAN LOCATED AT P. GARCIA STREET IN BARANGAY SAN ANTONIO, DISTRICT I, QUEZON CITY, TO ANGEL P. MERCADO BRIDGE.

WHEREAS, the Barangay Council of Barangay San Antonio, District I of this city has passed Resolution No. 043, S-2002, expressing the desire to name the bridge connecting Barangays San Antonio and Katipunan located at P. Garcia Street in San Antonio, District I, Quezon City, to Angel P. Mercado Bridge;

WHEREAS, the late Kagawad Angel P. Mercado was the longest serving Kagawad of the Barangay, having been elected as Sitio I Vice Barrio Lieutenant from 1960 to 1969, Barrio Councilman from 1969 to 1979 and Barangay Councilman from 1979 to 1989;

WHEREAS, during his tenure, Kagawad Mercado has been regarded by his constituents as a man of integrity and dedication whose character was beyond reproach and worthy of emulation;

WHEREAS, it is only proper and fitting to give due recognition to the achievements of Kagawad Mercado by naming the bridge connecting Barangays San Antonio and Katipunan located at P. Garcia Street in his honor.



IN SESSION ASSEMBLED:


SECTION 1. The bridge connecting Barangays San Antonio and

approval.




