



ORDINANCE NO. SP-1235, S-2003

AN ORDINANCE CREATING ONE (1) ADDITIONAL PLANTILLA POSITION OF EDUCATION PROGRAM SPECIALIST II (SG-16) UNDER THE DIVISION OF CITY SCHOOLS AND APPROPRIATING THE AMOUNT FOR THE PURPOSE.

WHEREAS, it is provided in Section 458 (a)(1)(viii) of the Local Government Code of 1991, that the City Council has the duties, powers and functions to determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from the city funds and provide for expenditures for the proper conduct of programs, projects and services and activities of the city government;

WHEREAS, it is likewise declared the policy of the State under Section 2 of R.A. 675, otherwise known as "An Act Prescribing a Revised Compensation and Position Classification System" in the government service, equal pay for substantially equal work and to base differences in pay upon substantive requirements of the position determining the rate of pay;

WHEREAS, from the time that the other two (2) Educational Program Specialist II were given local designation as In-Charge of Non-Teaching Personnel and Infrastructure Coordinator, additional position should be created in order to prepare the work and assigned task and salary of the said personnel;

WHEREAS, said incumbent employees have appealed for this additional position and salary grade, the same being favorably endorsed by their Division Superintendent in a letter dated August 5, 2002;

WHEREAS, under the approved Personnel Schedule for FY 2000 of the Division of City Schools, there were three (3) positions for Education Program Specialist II (SG-16), and one (1) position for Education Program Specialist II which were created;

WHEREAS, in order to give equal credit for the aforementioned city paid employees, and in consonance with the existing governing rules and regulations, the City government should create said additional one plantilla position.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED,

SECTION 1. There is hereby created one (1) additional plantilla position of Education Program Specialist II under the Division of City Schools, Quezon City, 2nd District, Metro Manila.

SECTION 2. The amount is hereby appropriated from the savings of said Division taken from the general fund for CY 2002 for the period covering January 2002 to July 2002 derived from the salary of a vacant item of one (1) Legal Officer I.

SECTION 3. This ordinance shall take effect immediately upon its approval.




