ORDINANCE NO. SP- **1258**, S-2003

AN ORDINANCE GRANTING A MONTHLY INCENTIVE ALLOWANCE TO ALL DULY APPOINTED REGULAR BARANGAY SECURITY DEVELOPMENT OFFICERS (BSDOs) IN QUEZON CITY, AND ALLOCATING THE NECESSARY AMOUNT IN THE 2004 ANNUAL BUDGET OF QUEZON CITY.

WHEREAS, Barangay Security Development Officers (BSDOs) have proven their worth in minimizing lawlessness and public disorder in their respective barangays;

WHEREAS, sometime during the past administration, BSDOs were given financial assistance by the City government in recognition of their contribution to the maintenance of peace and order;

WHEREAS, to show the appreciation of the City government to these BSDOs and to encourage them to be even more diligent in the performance of their responsibilities, a form of incentive should be granted to these barangay peace officers;

WHEREAS, while financial constraint prevents the grant of the incentive outright, directing the inclusion in the next year's budget of the necessary amount will ensure that the benefit will be implemented by that time;

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. A monthly incentive allowance is hereby granted to each of the duly appointed regular Barangay Security Development Officers in Quezon City effective January 2004.



SECTION 3. This Ordinance shall take effect upon its approval.




