ORDINANCE NO. SP. 1261

AN ORDINANCE PROVIDING FOR THE FUND ALLOCATION FOR THE OPERATION AND MAINTENANCE OF THE DEVELOPMENT CENTER. SOCIAL SERVICES DEVELOPMENT DEPARTMENT.

WHEREAS, as provided for in Section 17 (a) of R.A. 7160, "xxx local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities enumerated herein";

WHEREAS, sub-section (b) 2 (iv) of Section 17, supra, likewise provides that basic services and facilities include social welfare services which include programs and projects on child and youth welfare, x x x numition services:

WHEREAS, PHI 5478 project, more particularly known as the "Street Children Nutrition and Educational Project" is now being implemented in thirteen (13) local government units of the Philippines;

WHEREAS, the Department of Interior and Local Government, by virtue of its mandate, which is to enhance the capability of local government units in the delivery of such basic services to their constituents, has been designated as the executing agency for the above-mentioned project;

WHEREAS, Quezon City, having been identified as one of those with considerable number of street children, has been selected as one of the implementers of the project due to its capacity to carry out and sustain a similar project in the future;

WHEREAS, under the revised PHI 5478 Plan of Operation, one of the outputs of the project is the construction and maintenance of a Social Development Center (SDC) in Quezon City to support the City's social growth and development program;

WHEREAS, the Social Development Center (SDC) shall serve the following functions;

- a. Adjunct office of the LGU's Social Services Department in the effective delivery of the basic social services to its clientele.
- b. Base of the project secretariat in each beneficiary area.
- c. Multi-purpose training center for social workers, project volunteers and beneficiaries, and the LGU's other social services clientele.
- d. Processing and drop-in center for street children and other children in especially difficult circumstances.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Provision of funding for the operation and maintenance of Social Development Center (SDC) shall be included in the General Appropriations Act of Quezon City in the year 2004.

SECTION 2. Statement of Purpose. - The principal purpose shall be as follows:

- To provide processing, study and diagnostic center and temporary shelter for street children and other children in especially difficult circumstances.
- 2. To provide skills training and other seminars to prepare them in the reintegration to their respective families/communities.





SECTION 3. Organization. - The Social Development Center (SDC) will be manned by the personnel of Social Services Development Department (SSDD) to be augmented by additional contractual employees who will provide services to targeted clients/beneficiaries.

SECTION 4. Location and Facilities. - The SDC will be located at Molave Street, Payatas, Quezon City.

SECTION 5. Funding. - Operational fund will be integrated in the regular fund of the Social Services Development Department in the General Provision Act of Quezon City in the year 2004.

All moneys and other forms of assistance to the Center shall be fully recorded and shall be subject to auditing and accounting rules and regulations and inventory.

SECTION 6. Effectivity. - This Ordinance shall take effect upon its approval.
