ORDINANCE NO. SP- **1269**, S-2003

AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS TO INCREASE TICKET PRICES BY ONE PESO (P1.00) DURING THE ENTIRE MONTH OF SEPTEMBER 2003 FOR THE PURPOSE OF SUPPORTING THE SCOUTING PROGRAM OF THE QUEZON CITY GIRL SCOUT.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. All cinema owners and operators in Quezon City are hereby required to increase theater admission prices by One Peso (P1.00) for the entire month of September 2003.


SECTION 2. All proceeds from this fund raising shall be used exclusively to finance all programs and activities of the Quezon City Girl Scouts.

SECTION 3. This Ordinance shall take effect immediately upon its approval.




