ORDINANCE NO. SP- **1270**, S-2003

AN ORDINANCE APPROPRIATING THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (P400,000.00), OR SO MUCH THEREOF AS MAY BE NECESSARY FOR THE COMPLETION OF THE BARANGAY STA. CRUZ MULTI-PURPOSE BUILDING LOCATED AT NO. 19 ROOSEVELT AVENUE IN BARANGAY STA. CRUZ.

WHEREAS, the said building will house the Office of the Barangay Council, Barangay Captain and its staff, Office of the SK Chairman and its staff and also for the Computer Section and the extension of the Nutrient Post.


NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:



SECTION 2. This Ordinance shall take effect upon its approval.




