ORDINANCE NO. SP- 1276 S-2003

AN ORDINANCE PROHIBITING VEHICLES ALONG E. RODRIGUEZ AVENUE IN THE DIRECTION OF MANILA FROM ENTERING 14TH STREET AND LIKEWISE, VEHICLES COMING FROM 14TH STREET TO MAKE A LEFT TURN OR U-TURN AT E. RODRIGUEZ AVENUE, BARANGAY MARIANA, QUEZON CITY.

Introduced by Councilors JESUS MANUEL C. SUNTAY, ALMA F. MONTILLA, ANTONIO E. INTON, JR., JANET M. MALAYA, RICARDO R. DEL ROSARIO and RESTITUTO B. MALAÑGEN.

WHEREAS, Section 21 (d) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that, "Any city, x x x may, by a duly enacted ordinance, x x x regulate the use of any local street, road or thoroughfare, x x x";

WHEREAS, the Barangay Council of Barangay Mariana, Quezon City has passed a resolution urging the Quezon City Council to pass an ordinance prohibiting vehicles along E. Rodriguez Avenue towards the direction of Manila from entering 14th Street and likewise, prohibiting vehicles coming from 14th Street to make a left turn or u-turn at 14th Street to E. Rodriguez Avenue;

WHEREAS, 14th Street corner E. Rodriguez Avenue, Barangay Mariana, District IV, this City, tends to become an accident-prone area when vehicles coming from E. Rodriguez Avenue make a left turn at 14th Street and likewise to vehicles making a left turn at 14th Street to E. Rodriguez Avenue;

WHEREAS, the said street is being used as an alternative route of motorists going to Manila and Cubao;

WHEREAS, the approval of this Ordinance is imperative to prevent traffic congestion and vehicular accident at E. Rodriguez Avenue corner 14th Street, Quezon City.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY
IN SESSION ASSEMBLED:

SECTION 1. PROHIBITION. - Vehicles coming from E. Rodriguez Avenue towards the direction of Manila are prohibited to enter 14th Street and likewise, vehicles coming from 14th Street to make a Left Turn at E. Rodriguez Avenue.


SECTION 2. INSTALLATION OF ONE-WAY STREET SIGN. - The Department of Public Order and Safety (DPOS) is hereby mandated to install a No Entry and No Left Turn or No U-Turn signs at the corner of 14th Street and E. Rodriguez Avenue for the information of the motorists using the same.


SECTION 3. EFFECTIVITY. - This Ordinance shall take effect immediately upon its approval.
