

ORDINANCE NO. SP-1338, S-2003

AN ORDINANCE AMENDING ORDINANCE NO. SP-1191, SERIES-2002. GRANTING "INCENTIVES FOR BARANGAYS UTILIZING OWN TRUCKS FOR WASTE COLLECTION" AND GIVING IT RETROACTIVE EFFECT.

WHEREAS, Ordinance No. SP-1191, S-2002, was signed into law by the Honorable Mayor Feliciano R. Belmonte, Jr. on 16 December 2002, providing incentive for barangays utilizing their own dump trucks for solid waste collection services within their own territorial jurisdiction;

WHEREAS, there are barangays who have been utilizing their own dump trucks for solid waste collection, compliant with existing policies and systems on suitable environment protection and waste management, prior to the enactment and approval of Ordinance No. SP-1191, S-2002, qualifying them to the criteria and benefits set under the same ordinance;

WHEREAS, the self-reliance and self-sufficiency of these barangays have resulted in a considerable reduction in cost for hauling contracts and solid waste collection services on the part of the City government;

WHEREAS, prior qualified barangays should be able to avail of the incentives provided under the provisions of Ordinance No. SP-1191, S-2002 by giving said ordinance a retroactive effect.


NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


SECTION 1. RETROACTIVE EFFECT. - In so far as it shall benefit barangays which qualify to the criteria set forth under Section 3, Ordinance No. SP-1191, S-2002, the same Ordinance is hereby amended and given retroactive effect to January 1, 2002.

SECTION 2. EFFECTIVITY. - This Ordinance shall take effect immediately upon its approval.




