AN ORDINANCE GRANTING A FRANCHISE TO KABUHAYAN CENTER, INC. FOR THE OPERATION OF A WET AND DRY MARKET AT DON GREGORIO STREET, BARANGAY BAGBAG, NOVALICHES, QUEZON CITY, WHICH HAVE BEEN EXISTING SINCE 1989.

WHEREAS, Kabuhayan Center, Inc. a juridical personality created and existing under Philippine laws, the primary purpose is to operate a wet and dry market at Don Gregorio Street, Barangay Bagbag, Novaliches, Quezon City;

WHEREAS, through its president, Edwin G. Roman, expressed the intention of the corporation to apply for a franchise availing of the exemptions granted by Ordinance No. 1271, S-2003; copy of the letter attached as annex "A";

WHEREAS, the Barangay Council of Barangay Bagbag through Resolution No. 163, Series of 2003, certified the existence of the flea market in the said given address, a copy of the Resolution attached as annex "B", reinforced by an affidavit of the past Barangay Captain Constanca V. Ambita, stating therein the fact of its existence, copy likewise attached as annex "C";

WHEREAS, in order to give the residents surrounding the area an easy access to a public market and sanction its operation, it is imperative to grant the Kabuhayan Center, Inc. a franchise, pursuant to Section 458 (3) VII of the Local Government Code.




NOW, THEREFORE,

IN SESSION ASSEMBLED:


SECTION 1. There is hereby granted a franchise to Kabuhayan Center Inc. to operate a wet and dry market at Don Gregorio Street, Barangay Bagbag, Novaliches, Quezon City, exempting the same from the payment of franchise tax and other regulatory requirements as mandated by Section 2, Ordinance No. 2771, S-2003.

SECTION 2. This Ordinance shall take effect upon its approval.




