## ORDINANCE NO. SP- 1374, S-2004

AN ORDINANCE IMPOSING AN ADDITIONAL ONE PESO (P1.00) TO ADMISSION FEES IN ALL CINEMAS IN QUEZON CITY, FROM MAY 1 TO 31, 2004, THE PROCEEDS THEREOF TO BE DONATED TO THE QUEZON CITY RED CROSS IN CONNECTION WITH ITS COMMUNITY-BASED PROJECTS.

WHEREAS, Quezon City Red Cross is focusing on community-based projects designed to improve the capabilities of vulnerable barangays to cope the disaster situations and basic health problems through series of Red Cross initiated skills training;

WHEREAS, they also wanted to improve their facilities in blood transfusion and conducting a citywide campaign on voluntary blood donation in order to meet the spiraling needs of blood of our countless indigent patients whose recovery is retardate due to unavailability of blood;

WHEREAS, this program will only materialize if they have a sufficient resources to support the project;

WHEREAS, to show the support of the Quezon City government, it intends to increase by One Peso (P1.00) the admission fees in cinemas in the City, the proceeds thereof to be donated to Quezon City Red Cross.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Admission fees in all cinemas or movie houses in Quezon City re hereby increase by One Peso (P1.00) from May 1 to 31, 2004.
