AN ORDINANCE IMPOSING AN ADDITIONAL ONE PESO (P1.00) TO ADMISSION FEES IN ALL CINEMAS IN QUEZON CITY, FROM MARCH 1 TO 31, 2004, THE PROCEEDS THEREOF TO BE DONATED TO THE LAGARIAN CREEK ENVIRONMENTAL ASSOCIATION, INC. (LACREA) INCONNECTION WITH ITS SAGIP BATIS PROJECT.
