ORDINANCE NO. SP- 1384 "S-2004

AN ORDINANCE EXEMPTING CERTAIN PRIVATE MARKETS AND SLAUGHTERHOUSES SPECIFIED HEREIN, FROM THE FRANCHISE REQUIREMENT AS PROVIDED UNDER SECTION 1, CHAPTER VI11 OF ORDINANCE NO. SP-944, S-2000.

WHEREAS, the City Council is aware that a considerable number of public markets and slaughterhouses, notwithstanding their lack of a franchise to operate as mandated, have timely and substantially complied with the provisions of the Quezon City Market Code and Revenue Code;

WHEREAS, the application and implementation of the Quezon City Market Code should be pursuant to the principle that those who are in substantial compliance with the law should be given a certain degree of incentive and that the law should be applied prospectively,

WHEREAS, the following private markets and/cr slaughterhouses:

- 1. Bonifacio Market
- 2. Cloverleaf Market
- 3. MC Market
- 4. Visayas Market
- 5. C.I. Market
- 6. Oriental Market

- 7. Fairview market
- 8. Novaliches Market
- 9. Muñoz Market
- 10. Susano Market
- 11. Novaliches Slaughterhouse

a number of which have been in existence even prior to the enactment of both the Local Government Code of 1991 (Republic Act No. 7160) and the Quezon City Market Code, have timely and substantially complied with the provisions of the Quezon City Market Code;

WHEREAS, exempting the above-specified private markets/slaughterhouses from the franchise requirement under the Quezon City Market Code will in effect promote the general welfare of our beloved constituents as there will no longer be an imposition of an additional franchise tax or financial burden that the market and slaughterhouse and operators will be passing on to the consumers—our constituents.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED.

SECTION 1. The following private markets and/or slaughterhouses, to wit:

- 1. Bonifacio Market
- 2. Cloverleaf Market
- 3. MC Market
- 4. Visayas Market
- 5. C.I. Market
- 6. Oriental Market

- 7. Fairview Market
- 8. Novaliches Market
- 9. Muñoz Market
- 10. Susano Maket
- 11. Novaliches Slaughterhouse

are exempt from the franchise requirement as provided for under Section 1, Chapter VIII of Ordinance No. SP-944, S-2000

SECTION 2. This Ordinance shall take effect upon its approval.
