ORDINANCE NO. SP- **1392**, S-2004

AN ORDINANCE TO RENAME CULIAT HIGH SCHOOL, TANDANG SORA ANNEX TO TANDANG SOFA NATIONAL HIGH SCHOOL AND TO DECLARE ITS SEPARATION FROM ITS MOTHER SCHOOL, CULIAT HIGH SCHOOL.

WHEREAS, Department of Education Culture and Sports (DECS) Order No. 84, S-1996, provides all the necessary requirements for a Public Secondary Annexes with the authority to be separated from their mother institution;

WHEREAS, Culiat High School Tandang Sora Annex was established on June 1999 with an initial enrollment of three hundred twenty-eight (328) first year students located at Barangay Tandang Sora building which was converted into classrooms and school office pending the completion of the construction of the school building;

WHEREAS, Culiat High School, Tandang Sora Annex has now an enrollment increase of 13.4% totalling the current population of students to one thousand seven hundred sixteen (1,716) students;

WHEREAS, Culiat High School Tandang Sora Annex has now a four (4) storey building and another four (4) storey annex building which is currently under construction with a total number of thirty-two (32) classrooms in addition to the main building which also serves as a multi-purpose hall, more than enough to meet the requirements of the students of an independent high school;

WHEREAS, the need to make Culiat High School, Tandang Sora Annex, an independent school, separated from its mother institution is but urgent to provide the students residing within the area greater access to education and much improved environment and facilities conducive for learning;

WHEREAS, the mother school, Culiat High School including its teaching force, administrator, personnel, parents and students as well as whole community of Barangay Tandang Sora and other nearby barangays firmly believe that it is high time for the school to be granted its independence.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Culiat High School, Tandang Sora Annex is hereby renamed to Tandang Sora National High School and is hereby declared totally independent and separate from the Culiat High School (Main) located at Barangay Culiat, District II, Quezon City.


SECTION 2. The land where the school is located shall be for the exclusive use of the school.

SECTION 3. This Ordinance shall take effect upon its approval.




