ORDINANCE NO SP- 1402 , S-2004

AN ORDINANCE AUTHORIZING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE JR., TO CREATE, ESTABLISH AND INSTITUTIONALIZE THE LITTLE LEAGUE OF QUEZON CITY WITH THE OBJECTIVE OF PROVIDING AN AVENUE FOR OUR PUBLIC SCHOOL STUDENTS A CHANCE TO GET A COLLEGE EDUCATION FOR FREE THRU ATHLETIC SCHOLARSHIP AS WELL AS TO APPROPRIATE THE SUM OF TWO HUNDRED THOUSAND PESOS (P200,000.00) ANNUALLY FOR THE OPERATIONS AND OTHER TRAINING REQUIREMENTS OF THE LEAGUE.

WHEREAS, the Little League of Quezon City was organized last November 2001 with the objective of implanting firmly in the children of Quezon City the ideals of good sportsmanship, honesty, loyalty, courage and respect for authority so that these youngsters may well be adjusted, stronger and happier kids;

WHEREAS, active athleticism and competitive sports participation will bestow honor and pride to the citizenry of Quezon City,

WHEREAS, these youngsters through active participation in sports, particularly in baseball and softball, would grow to be good, decent, healthy and trustworthy well meaning citizens;

WHEREAS, these youngsters belong to the lower stratum of the Philippine economic society and that their parents would be very thankful and grateful that their children are able to enter college with minimal expense on their part,

WHEREAS, in long term the institutionalization of the Little League of Quezon City will provide an avenue for our public school students a chance to get a college education for free through athletic scholarship and motivate them to develop the necessary character traits that will make better professionals, industrialists or entrepreneurs after their Little League experience;


WHEREAS, in this way, these youngsters will become productive residents and future leaders of Quezon City.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


