ORDINANCE NO SP- **1403**, s-2004

AN ORDINANCE ESTABLISHING A 24- HOUR LYING-IN CLINIC IN BAGO BANTAY HEALTH CENTER, DISTRICT I, QUEZON CITY.

Introduced by Councilor ELIZABETH A. DELARMENTE, VICTOR V. FERRER, JR., RAMON P. MEDALLA, ERIC Z. MEDINA, MARY ANN L. SUSANO, JORGE L. BANAL, JULIAN M.L. COSETENG, JESUS MANUEL C. SUNTAY, ANTONIO E. INTON, JR., RESTITUTO B. MALAÑGEN and XYRUS L. LANOT.

WHEREAS, the City Council is mandated to formulate legislative measures that would ensure efficient delivery of needed medical services to its constituency;

WHEREAS, there is at present a health center operating in Bago Bantay area which caters innumerable patients from three barangays, specifically Barangays Ramon Magsaysay, Alicia and Sto. Cristo, District I, this City;

WHEREAS, there is a need to maximize the services delivered in the said health center in order to fully provide a comprehensive and complete medical services to the community;

WHEREAS, considering the importance of services rendered for maternal and pre-natal care, there is a need to provide obstetrics and gynecology services in the said center so as to truly achieve the aforesaid purpose;

WHEREAS, there is a need to establish a 24 hour lying-in clinic in Bago Bantay Health Center that would render services to mothers in the said area.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED.

SECTION 1. There is hereby established in Bago Bantay Health Center a 24 Hour Lying-In Clinic created to render obstetrics and gynecology services including related services to all residents of three barangays in the said area.


SECTION 2. The said clinic will extensively operate for twenty-four (24) hours and will be manned by competent obstetrician and gynecologist duly assigned by the City Health Department.

SECTION 3. This Ordinance shall take effect immediately upon its approval.




