ORDINANCE NO. SP-369, S-96

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF GREEN GROVE VILLA, SITUATED AT LOTS 9-B AND 10, BLOCK 28, NO. 17 LANTANA ST., BARANGAY MARIANA, QUEZON CITY, AS APPLLIED FOR BY G. T. GO REALTY, SUBJECT TO COMPLIANCE WITH THE CONDITIONS PRESCRIBED UNDER ORDINANCE NO. SP-56, S-93, PD 957 AND 1096, AS AMENDED.
