ORDINANCE NO. SP-393 S-96

AN ORDINANCE GRANTING AMUSEMENT TAX EXEMPTION TO THE PHILIPPINE NATIONAL RED CROSS FOR THE FILM SHOWING OF "BALTO", FOR THE DURATION OF ITS SHOWING ON MAY 8 TO 21, 1996, AS PROVIDED FOR UNDER PD 1643 AND SECTION 192 OF R.A. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Section 192 of the Local Government Code provides that "Local Government units may, through ordinances duly approved, gant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary";

WHEREAS, the Philippine National Red Cross or PNRC is a nongovernmental organization that helps our countrymen in times of distress, calamities and the like;

WHEREAS, the PNRC needs to raise funds for this noble cause;

WHEREAS, pursuant to Section 4 (b) of PD 1643, the PNRC shall be exempt from payment of all duties, taxes, fees and other targes of all kinds on all importations and purchases for its melusive use, on donations for its disaster relief and other Red tross services, and in its benefits and fund-raising drives, all revisions of laws to the contrary notwithstanding";

WHEREAS, the PNRC is raising funds through the film showing "Balto" for the duration of its showing on May 8 to 21, 1996;

whereas, the grant of exemption from the prayment of musement taxes constitutes Quezon Cit in the control of the PNRC;
