ORDINANCE AUTHORIZING THE INSTALLATION OF STEEL GATES AT SCOUT DELGADO AND SCOUT REYES, SCOUT LOZANO AND SCOUT REYES, SCOUT MAGBANUA AND SCOUT REYES, SCOUT MAGBANUA AND MOTHER IGNACIA AVENUE SCOUT LOZANO AND MOTHER IGNACIA AVENUE LOCATED IN SCOUT LOZANO AND MOTHER IGNACIA AVENUE LOCATED IN SCOUT LOZANO, THIS CITY.

WHEREAS, the Local Government Code empowers local government units to measures necessary to promote the health and safety, maintain peace and order reserve the comfort and convenience of their inhabitants;

WHEREAS, rising criminalities in the country has risen into an alarming that every citizen must take precautionary measures in order to ensure peace order and for the protection of their life and property;

WHEREAS, there are reports of snatching, hold-up, carnapping, robbery in the area, and the entry's of perverts and maniacs not residents of the area,

WHEREAS, the homeowners of Scout Delgado, Scout Lozano, Scout Lozano and Scout Castor Streets have signed a petition for the installation of steel along their streets;

WHEREAS, the installation of steel gates on the streets mentioned will enable streets to monitor incoming and outgoing vehicles, pedestrians especially at the sours of the night.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SON ASSEMBLED:

SECTION 1. The installation of steel gates at Scout Delgado and Scout Reyes (Gate 4), Scout Lozano and Scout Reyes (Gate 5), Scout Castor and Scout Reyes (Gate 6), Scout Magbanua and Roces Avenue (Gate 1), Scout Magbanua and Mother Ignacia Avenue (Gate 3), Scout Lozano and Mother Ignacia Avenue (Gate 2) along Barangay Paligsahan as indicated in the attached map, is hereby authorized.

SECTION 2. The gates shall be manned by private security guards to be hired by the residents of the designated areas as mentioned in Section 1 hereof.

SECTION 3. The expenses for the installation of the steel gates shall be shouldered by the petitioner homeowners concerned.

SECTION 4. The gates mentioned in Section 1 of this Ordinance shall be closed at 10:00 p.m. and opened at 5:00 a.m. the following day, except gate 1 which will be manned by security guards which shall serve as entry and exit points during said hours.

SECTION 5. The installation of the steel gates shall be made only after consultation with the City Engineer's Office and proper police authorities and after a public hearing shall have been conducted.

SECTION 6. A copy of the petition and the barangay map are hereto attached and made integral parts of this Ordinance for the proper implementation of the project.

SECTION 7. This Ordinance shall take effect immediately upon its approval.
