ORDINANCE NO. SP- 2678 , S-2018

AN ORDINANCE ALLOWING THE DISPOSITION OF THE REMAINING DISPOSABLE PORTION OF A PARCEL OF LAND LOCATED ALONG BATINO AND PALOSAPIS STREETS, BARANGAY AMIHAN, QUEZON CITY, IDENTIFIED AS LOT 2-C, PSD, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 77540, REGISTERED UNDER THE NAME OF QUEZON CITY GOVERNMENT, CONTAINING AN AREA OF MORE OR LESS THREE THOUSAND EIGHT HUNDRED SIXTY FIVE SQUARE METERS AND EIGHTY SQUARE DECIMETERS (3,865.80) IN FAVOR OF THE QUALIFIED ON-SITE INFORMAL SETTLER FAMILIES (ISFs).

WHEREAS, in 1982, a parcel of land located along Batino Street and Palosapis Street Barangay Amihan, Quezon City, identified as Lot 2, BSD-11020, covered by Transfer Certificate of Title (TCT) No. 262134, containing a gross area of more or less 4,115.80 square meters, was registered under the name of the Quezon City Government (LGU-QC), photo copy of the title is hereto attached as "Annex A" and made as an integral part hereof;

WHEREAS, from 1983 to 1994, portions of the above-cited lot had been disposed of to qualified buyer-beneficiaries by the Quezon City Legal Department, which disposition had resulted to the subdivision of Lot 2, BSD-11020 into three (3) lots namely: Lot 2-A, PSD-13-015271 (130 square meters); Lot 2-B, PSD-13-015271 (120 square meters) and Lot 2-C, PSD-13-015271 (3,865.80 square meters). Lot 2-C in particular is covered by TCT No. 77540 and still registered under the name of LGU-QC, photo copy of the title of Lot 2-C is hereto attached as "Annex B" and made as an integral part hereof;

WHEREAS, the Housing Community Development and Resettlement Department (HCDRD), previously Urban Poor Affairs Office (UPAO), had already conducted a survey of the structures at the area as well as preparation of preliminary subdivision schemes;

WHEREAS, to determine the price of the said property, this will be referred to the Appraisal Committee, for accurate, justifiable and fair assessment for the beneficiaries and the implementation of the project;

WHEREAS, pursuant to Section 455 (b)(1) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. To dispose of the remaining disposable portions of a parcel of land located along Batino and Palosapis Streets, Barangay Amihan, Quezon City, identified as Lot 2-C, PSD-13-015271, covered by Transfer Certificate of Title No. 77540, registered under the name of Quezon City Government, containing an area of more or less 3,865.80 square meters, in favor of the qualified on-site informal settler families (ISFs).

SECTION 2. To segregate and allocate to Barangay Amihan, a portion of Lot-2-C, where the barangay facilities are located, containing an Area of more or less 500 square meters.

SECTION 3. This Ordinance shall take effect upon its approval.
