AN ORDINANCE WITHDRAWING FROM PUBLIC USE THE DONATED MARKET SITE OF BUENAMAR SUBDIVISION LOCATED IN BARANGAY NOVALICHES PROPER, QUEZON CITY COVERED BY TRANSFER CERTIFICATE TITLE (TCT) NO. 157564 CONTAINING AN AREA OF TWO THOUSAND ONE HUNDRED THREE (2,103) SQUARE METERS, MORE OR LESS.

WHEREAS, on June 3, 1975, a Deed of Donation was executed between the Quezon City Government as the Donee and Maria C. Vda. De Tancinco as the Donor for a market site of Buenamar Subdivision located at Barangay Novaliches Proper, Quezon City containing an area of Two Thousand One Hundred Three (2,103) square meters or less described as Lot 13 Block 4 (LRC) Pcs-941;

WHEREAS, it has been forty four years (44) years and the area has never been developed as a market site and is currently occupied by informal settler families (ISFs);

WHEREAS, no revocation was made by the Donor for this non-development of the market site and any action to revoke said donation has already prescribed under Article 764 of the Civil Code of the Philippines;

WHEREAS, Article 422 of the Civil Code of the Philippines provides that "Property of public dominion, when no longer intended for public use or for public service, shall form part of the patrimonial property of the State".

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

Section 1. It is hereby withdrawn from the public use, the donated market site of Buenamar Subdivision located at Barangay Novaliches Proper, Quezon City covered by Transfer Certificate of Title (TCT) No. 157564, containing an area of Two Thousand One Hundred Three (2,103) square meters, more or less.

Section 2. Upon withdrawal of the said property from public use, the same is hereby subjected to evaluation for its best possible use. χ
