WHEREAS, Presidential Decree No. 491, also known as the “Nutrition Act of the Philippines,” created the National Nutrition Council (NNC) and mandates all local government units to formulate, adopt, and implement local nutrition action plans to address malnutrition and promote food security;

WHEREAS, the Quezon City Government, through its Nutrition Committee, has developed the Quezon City Local Nutrition Action Plan (QC LNAP) for Calendar Year 2025, which outlines evidence-based strategies, programs, and interventions to reduce malnutrition, ensure food security, and promote the overall well-being of Quezon City residents, particularly children, pregnant women, and other nutritionally-vulnerable groups;

WHEREAS, the adoption of the QC LNAP is aligned with the Philippine Plan of Action for Nutrition (PPAN) 2023-2028, the Sustainable Development Goals (SDGs), particularly Goal No. 2 (Zero Hunger) and Goal No. 3 (Good Health and Well-being), and the Quezon City Government’s commitment to creating a well-nourished, food-secure, and resilient community.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to adopt, as it does hereby adopt, the Quezon City Local Nutrition Action Plan (QC LNAP) for 2025 as the guiding framework for the City’s nutrition programs and initiatives.

RESOLVED FURTHER, that the copy of the Quezon City Local Nutrition Action Plan (QC LNAP) for 2025 shall be made integral part of this Resolution.

RESOLVED FURTHERMORE, that all relevant City departments, offices, barangays, and stakeholders are hereby directed to ensure the proper implementation, monitoring, and evaluation of the QC LNAP in accordance with its strategies and targets, and to integrate the same within their respective programs, activities, and budgets.
