A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO AND SIGN THE DEED OF DONATION OF TWENTY (20) UNITS OF PORTABLE RADIO WITH BATTERY PACK AND CLIP CHARGER, A BASE SYSTEM, AND REPEATER SYSTEM TO BARANGAY CLARO, DISTRICT III, QUEZON CITY, AND AUTHORIZING THE TRANSFER OF OWNERSHIP OF THE SAME TO AND WITHOUT COST TO THEIR RECIPIENT

WHEREAS, to improve the communication among the staff and the Barangay Public Safety Officer (BPSO) of Barangay Claro, twenty (20) units of portable radio with battery pack and clip charger, a base system, and repeater system were purchased through the funds of Councilor Don S. De Leon;

WHEREAS, to effectively transfer the ownership of the abovementioned items to the recipient Barangay, a Deed of Donation shall be executed, with the City assuming all fees and costs;



WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into and sign the Deed of Donation of Twenty (20) Units of Portable Radio with Battery Pack and Clip Charger, a Base System, and Repeater System to Barangay Claro, District III, Quezon City, and authorizing the transfer of ownership of the same to and without cost to their recipient.
