Ordinance No. NC- 36, S-88

ORDINANCE

CREATING FIVE (5) CONTRACTUAL POSITIONS UNDER THE OFFICE OF EACH CITY COUNCILOR AND APPROPRIATING THE SUM OF FOUR MILLION EIGHT HUNDRED THOUSAND PESOS (P4,800,000.00) TO COVER THE SALARIES AND OTHER PERSONNEL EXPENSES OF SUCH POSITIONS COVERING THE PERIOD FROM MAY 1 TO DECEMBER 31, 1988, THE AMOUNT OF THREE MILLION FIVE HUNDRED ELEVEN THOUSAND ONE HUNDRED FIFTY-SIX PESOS (P3,511,156.00) THEREOF TO BE TAKEN THRU REVERSION FROM CERTAIN APPROPRIATIONS FOR PERSONNEL SERVICES UNDER THE OFFICE OF THE CITY SECRETARY AND FROM OTHER SERVICES UNDER THE CITY COUNCIL, THE BALANCE TO BE TAKEN FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. There is hereby created under the Office of each City Councilor the following contractual positions, to wit:

- a) 1-Technical Assistant II - P8,000.00 per month
- b) 2-Technical Assistant I - 6,000.00 each per month
- c) 2-Legislative Coordinator- 2,500.00 each per month

SECTION 2. There is hereby reverted to the general fund the sum of Three Million Five Hundred Eleven Thousand One Hundred Fifty-Six Pesos (P3,511,156.00), One Million Two Hundred Thirty Five Thousand Nine Hundred Fifty-Six Pesos (P1,235,956.00) to be taken from the appropriation for salaries and other personnel expenses of forty-eight (48) proposed positions under the Office of the City Secretary and Two Million Two Hundred Seventy-Five Thousand Two Hundred Pesos (P2,275,200.00) to be taken from the appropriation for Other Services under the Office of the City Council.

SECTION 3. There is hereby appropriated the sum of Four Million Eight Hundred Thousand Pesos (P4,800,000.00) to be made available to cover the payment of the salaries and other personnel expenses of the contractual positions created under Section One hereof covering the period from May 1 to December 31, 1988; PROVIDED, that the amount of Three Million Five Hundred Eleven Thousand One Hundred Fifty Six Pesos (P3,511,156.00) shall be taken from the sum reverted under Section Two hereof and the deficiency amounting to One Million Two Hundred Eighty Eight Thousand Eight Hundred Forty Four Pesos (P1,288,844.00) shall be taken from any available funds in the City Treasury.

SECTION 4. This Ordinance shall take effect as of May 1, 1988.
