FOR THE OPERATION OF AN E-POKER AND E-TONGITS ESTABLISHMENT AT 4TH FLOOR NEW FARMERS PLAZA, BARANGAY SOCORRO, ARANETA CENTER, CUBAO, DISTRICT III, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

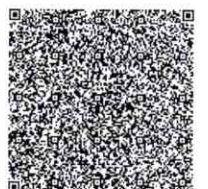

WHEREAS, GameMaster Integrated, Inc., a domestic corporation duly organized and existing under and by virtue of Philippine laws, is applying for a Special Permit to operate an E-Poker and E-Tongits establishment with business address at 4th Floor New Farmers Plaza, Barangay Socorro, Araneta Center, Cubao, District III, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of the same Electronic Gaming (E-Poker and E-Tongits Games) through Quezon City Resolution No. SP-9575, S-2024;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit pursuant to an existing City ordinance;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit to business activities of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Gamemaster Integrated, Inc. for the operation of an E-Poker and E-Tongits establishment at 4th Floor New Farmers Plaza, Barangay Socorro, Araneta Center, Cubao, District III, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an E-Poker and E-Tongits establishment granted herein shall be subject to the following conditions:

1. the holding of E-Poker and E-Tongits shall be in accordance with the rules and regulations promulgated by PAGCOR;
2. the operation of an E-Poker and E-Tongits establishment shall not include playing of games not related to or other than E-Poker and E-Tongits;
3. the operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below 21 years of age or students of any school, college, or university;
4. GameMaster Integrated, Inc., shall remit a license fee of three percent (3%) of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution, in accordance with Section 25, Article III of Quezon City Ordinance No. SP-2773, S-2018 as amended; and
5. this Resolution is non-assignable, non-transferable, and site-address specific.


