

ORDINANCE NO. SP- 141, S-93

AN ORDINANCE APPROVING SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 1993 INVOLVING THE SUM OF FIVE MILLION NINE HUNDRED EIGHTEEN THOUSAND PESOS (P5,918,000.00) AND APPROPRIATING SAID AMOUNT FOR VARIOUS PURPOSES.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Supplemental Budget No. 2 appropriating the total amount of FIVE MILLION NINE HUNDRED EIGHTEEN THOUSAND PESOS (P5,918,000.00) necessary to meet additional expenditures of the City is hereby approved. The budget document containing specific items of expenditures (copy attached) is hereby made an integral part of this Ordinance.


SECTION 2. The appropriation of Five Million Nine Hundred Eighteen Thousand Pesos (P5,918,000.00)

to meet said expenditures shall be taken from savings, as certified by the City Treasurer.


SECTION 3. This Ordinance shall take effect upon its approval.
