A RESOLUTION RENEWING THE SPECIAL PERMIT OF AB LEISURE EXPONENT INCORPORATED TO OPERATE TRADITIONAL AND ELECTRONIC BINGO ESTABLISHMENT AT LOWER GROUND FLOOR, SM CITY-NORTH ANNEX BUILDING, EDSA, BARANGAY BAGONG PAG-ASA, DISTRICT I, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

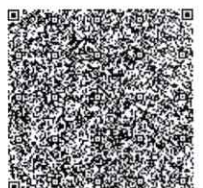

WHEREAS, AB Leisure Exponent Incorporated, a domestic corporation duly organized and existing under and by virtue of Philippine laws, is applying for the renewal of Special Permit to operate a Traditional and Electronic Bingo establishment located at Lower Ground Floor, SM City-North Annex Building, EDSA, Barangay Bagong Pag-asa, District I, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of the same Traditional and Electronic Bingo establishment through Quezon City Resolution No. SP-9577, S-2024;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit pursuant to an existing City ordinance;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a special Permit to business activities of the same nature.

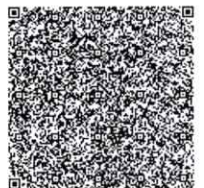
NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of AB Leisure Exponent Incorporated to operate a Traditional and Electronic Bingo establishment at Lower Ground Floor, SM City-North Annex Building, EDSA, Barangay Bagong Pag-asa, District I, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate a Traditional and Electronic Bingo establishment granted herein shall be subject to the following conditions:

1. the holding of Traditional and Electronic Bingo shall be in accordance with the rules and regulations promulgated by PAGCOR;
2. the operation of Traditional and Electronic Bingo establishment shall not include playing of games not related to or other than Traditional and Electronic Bingo;
3. the operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below 21 years of age or students of any school, college, or, university;
4. AB Leisure Exponent Incorporated shall remit a license fee of three percent (3%) of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution, in accordance with Section 25, Article III of Quezon City Ordinance No. SP-2773, S-2018, as amended; and
5. this Resolution is non-assignable, non-transferable, and site-address specific.

*RESOLVED FINALLY, that this renewal of Special Permit to operate a Traditional and Electronic Bingo establishment shall be valid for a period of three (3) years from the approval of this Resolution and may be renewed by the City Council.*
