A RESOLUTION RENEWING THE SPECIAL PERMIT OF RIZAL GAMING CORPORATION TO OPERATE A TRADITIONAL AND ELECTRONIC BINGO GAMES ESTABLISHMENT LOCATED AT RMR SQUARE, TANDANG SORA AVENUE, BARANGAY PASONG TAMO, DISTRICT VI, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, Rizal Gaming Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws, is applying for the renewal of its Special Permit to operate a Traditional and Electronic Bingo Games establishment located at RMR Square, Tandang Sora Avenue, Barangay Pasong Tamo, District VI, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of the same Traditional and Electronic Bingo Games establishment through Quezon City Resolution No. SP-9255, S-2023;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit pursuant to an existing City ordinance;

WHEREAS, the operation of a Traditional and Electronic Bingo Games establishment is regulated and licensed by the Philippine Amusement and Gaming Corporation (PAGCOR);

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the Quezon City Council to grant or renew a Special Permit to business activities of the same nature;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Rizal Gaming Corporation, for the operation of a Traditional and Electronic Bingo Games establishment located at RMR Square, Tandang Sora Avenue, Barangay Pasong Tamo, District VI, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate a Traditional and Electronic Bingo Games establishment granted herein shall be subject to the following conditions, to wit:

1. the holding of Traditional and Electronic Bingo Games shall be in accordance with the rules and regulations promulgated by PAGCOR;
2. the operation of a Traditional and Electronic Bingo Games establishment shall not include the playing of games not related to or other than Traditional and Electronic Bingo Games;
3. the operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below 21 years of age or students of any school, college or university;
4. Rizal Gaming Corporation shall remit a license fee of three percent (3%) of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution, in accordance with Section 25, Article III of Quezon City Ordinance No. SP-2773, S-2018, as amended;
5. this Resolution is non-assignable, non-transferrable and site-address specific; and
6. the establishment shall not be a nuisance to public safety and order.


