*WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance;*

WHEREAS, the Quezon City Anti-Drug Abuse Advisory Council (QCADAAC) is the arm of the City in its fight against illegal drugs;

WHEREAS, QCADAAC is requesting for the purchase of one (1) unit of motor vehicle with the following specifications:
