A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PASCUAL LINER, INC. FOR THE OPERATION OF AS-BUILT: TRANSPORT GARAGE LOCATED AT LOTS 512-A-2, 512-A-3, AND 512-A-4, QUIRINO HIGHWAY, BARANGAY GULOD, DISTRICT V, QUEZON CITY, AS REQUIRED UNDER QUEZON CITY ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016

WHEREAS, pursuant to Section 55, Article VIII of Quezon City Ordinance No. SP-2502, S-2016, exceptions and variances or deviations from the provisions of the Zoning Ordinance may be allowed only upon authorization by the City Council, through a Resolution;

WHEREAS, the proposed project will not adversely affect public health, safety, and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, the applicant has complied with all the necessary requirements prescribed by law, ordinance, or administrative issuances in its application for the construction of the aforementioned project;

WHEREAS, the applicant has submitted all the necessary and mandatory, documentary and national government agency's requirements in support of the proposed project and has committed to comply with the provisions of existing laws, ordinances, and rules and regulations pertaining to public safety, environmental protection, and vehicular traffic.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to Pascual Liner, Inc. for the operation of As-Built: Transport Garage located at Lots 512-A-2, 512-A-3, and 512-A-4, Quirino Highway, Barangay Gulod, District V, Quezon City, as required under Quezon City Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.

RESOLVED FURTHER, that the Special Use Permit shall be annulled by operation of law, in case the Land Transportation Franchising and Regulatory Board and/or after appropriate government agency revokes the franchise of the applicant.

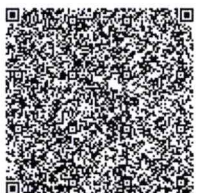



RESOLVED FINALLY, that only buses of the applicant company with appropriate body markings shall use the subject terminal.


